

# 2023 - 2024 Licence Agreement Information Document

## **Background**:

- Esitrain licences certain Energex/Ergon training courses and materials to external training providers for them to deliver on their behalf.
- This assists Esitrain with meeting the Contractor's training requirements in a more timely manner.

## **Policy Requirements:**

- At its discretion, Esitrain will determine the *eligibility* of an external training provider to enter into a Licence Agreement and the *courses* that are made available to them,
- Licence Agreements will run from 1<sup>st</sup> of July through to the 30<sup>th</sup> of June of each year,
- Prices for Licence Agreements will be determined by Esitrain (No pro-rata costing is available),
- The Terms and Conditions for Licence Agreements between Esitrain and external training providers will be determined via the *Esitrain Licence Agreement Contract*,
- Esitrain will no longer provide the option to record training outcomes for any other training courses. This is to be performed by the Licence Holder,
- Evidence of training outcomes is required to be made available to Esitrain within 2 business days' of the request.

### **Esitrain Licensee Eligibility Requirements:**

For an external training provider to be considered as an Esitrain Licensee, they must first provide evidence that their proposed trainer/s meet the 'Trainer Eligibility criteria' as well as providing evidence that they have, or have access to, a suitable training facility.

Each Trainer must hold all the items listed in the 'Eligibility criteria', applicable to the selected course/s, to be approved to deliver Esitrain Licenced training course/s.

#### Non- Electrical - Trainer Eligibility Criteria

- Current Certificate IV in Training and Assessment (TAE40116),
- Extensive Industry experience, through either Asset Inspector or Asset Inspector Management position servicing Energy Queensland (minimum of 5 years).
- Extensive knowledge of:
  - EQL Lines Defect Classification Manual (LDCM),
  - EQL Asset Inspection and Earth Testing Work Category Specifications (WCS)
  - EQL Suite of Standards for Asset Inspection and Earth Testing (S032, S033, S034, S036, S038, S040, S041, S042, S043)



#### Electrical - Trainer Eligibility Criteria

- Trainer/s current Certificate IV in Training and Assessment (TAE40116)
- Trainer/s have the relevant Electrical License/s to the deliver the requested training material
- Trainer/s holds the Authorisation/ training outcome for any of the requested training courses as deemed by the Electricity Entity (Note 1)
- Trainer/s have relevant experience in the Electrical Supply Industry
- Other requirements as determined by Esitrain to meet Esitrain's Quality and Compliance system

Note 1: Esitrain will accept a Trainer that has the National Unit of Competence (UETDREL006 - Work safely in the vicinity of live electrical apparatus as a non-electrical worker) to be eligible to deliver T0911 Introduction to Electrical Network Infrastructure for Authorised Persons.
